- g) to request the notification of third persons to whom the personal data are transferred, about the processes carried out within the scope of sub-clauses (d) and (e);
- h) to object to the processing, exclusively by automatic means, of your personal data, which leads to an unfavorable consequence for you;
- i) to claim compensation if you suffered damage due to unlawful processing of your personal data.

Pursuant to article 13 of the LPPD, data subjects should submit their requests to our Company in writing, or in other ways as will be determined by the Personal Data Protection Board (the "**Board**"). Within this scope, the applications to be made to our Company can be sent to us, free of charge, by printing out this form after filling it in and by selecting one of the four methods below.
