- f) Requesting the erasure or destruction of your personal data under the conditions referred to in Article 7,
- g) Requesting the reporting of the operations carried out pursuant to sub-paragraphs (e) and (f) to third parties to whom your personal data have been transferred,
- h) Objecting to the occurrence of a result against you by analyzing the data processed solely through automated systems,
- i) Claiming compensation for the damage you have suffered due to unlawful processing of your personal data.

As per Article 13 of the PDPL, data subjects shall submit their requests to our Company in writing or by other methods designated by the Personal Data Protection Board ("**Board**"). In this context, applications can be submitted to our Company free of charge after this form is filled in and printed out, choosing one of the four methods below.

In order for the data subject to make a request about the personal data relating to a person other than themselves, the original copy of a notary-approved special power of attorney with a wet signature, issued by the data subject on behalf of the applicant, shall be submitted.

In the event that the request submitted by the Data Subject requires an additional cost, our Company shall collect the fee specified in the tariff by the Personal Data Protection Board.

Your application shall be answered within thirty days from the date your request reaches our Company, depending on the nature of the request, in accordance with Article 13(2) of the PDP Law. Our response shall be delivered to you in writing or electronically as per Article 13 of the PDPL.
